AN ORDINANCE AMENDING ORDINANCE #428

BE IT ORDAINED BY THE CITY OF SUMNER,  
ILLINOIS, that:

It shall be unlawful to discharge any weapon, including, but not limited to, firearms, air guns, bows and cross bows, in the City or so that the bullet, missile, arrow, or projectile therefrom enters the City, without written permission from the Mayor, provided that this section shall not be construed to prohibit any officer of the law to discharge a weapon in the performance of his duty.

This ordinance shall be known as Ordinance Number \_\_\_\_\_ of the City Ordinances of Sumner.
