ORDINANCE NO. 555 A

AN ORDINANCE TO AMEND ORDINANCE NO. 555

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL of the City of Sumner, Lawrence County, Illinois, that Ordinance No. 555 of the Revised Code of Ordinances of the City of Sumner, Lawrence County, Illinois, entitled "AN ORDINANCE TO AMEND SECTION 8 OF ORDINANCE NO. 523A", shall be amended as follows:

IT IS THEREFORE ORDAINED AS FOLLOWS:

SECTION 8. Rate Schedule:

The following shall be the rates for the water supplied by the City:

The minimum monthly bill for users within the city limits will be as follows:

Min. (1000 gal.) = \$10.00

The minimum monthly bill will be payable regardless of use.

The monthly bill for users within the City limits will be computed as follows:

MIN (1000 GAL)	\$10.00
1,001 GALLONS TO 15,000 GALLONS	\$6.80/1000 GAL.
15,001 GALLONS TO 100,000 GALLONS	\$5.00/1000 GAL.
100,001 GALLONS AND UP	\$3.40/1000 GAL.

An additional \$3.00 surcharge shall be added to the monthly bill for users within the City limits each and every month.

The monthly bill for users outside the City limits will be computed as follows:

MINIMUM WATER CHARGE (1000 GAL)	\$15.00
1,001 GALLONS TO 15,000 GALLONS	\$10.20/1000 GAL.
15,001 GALLONS TO 100,000 GALLONS	\$7.50/1000 GAL.
100,001 GALLONS AND UP	\$3.90/1000 GAL.

An additional \$3.00 surcharge shall be added to the monthly bill for users outside the City limits each and every month.

Upon passage and approval, this Amendment to the Ordinance shall take effect and be effective ten days after publication as provided by law. Should any section or provision of this Amendment to the Ordinance be declared invalid by a Court of law, such decision shall not affect the validity of the remaining portions of the Ordinance, which shall remain in full force and effect.
