

ORDINANCE NO. 581

**AN ORDINANCE ESTABLISHING HIRING STANDARDS FOR  
PART-TIME POLICE OFFICERS OF THE CITY OF SUMNER, ILLINOIS**

WHEREAS, the City of Sumner, Illinois (City) is required to establish hiring standards for part-time police officers and submit those standards to the Illinois Law Enforcement Training Standards Board, pursuant to Section 3.1-30-21 of the Illinois Municipal Code (65 ILCS 5/3.1-30-21); and

WHEREAS, the Corporate Authorities of the City desire to maintain compliance with the aforesaid statutory mandate;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the City of Sumner, Illinois:

Section 1. All part-time police officers shall be required to enter and successfully complete a course on police procedure by the proper authorities as established by the Illinois Law Enforcement Training Standards Board within the prescribed time as established by such board, and shall otherwise successfully complete any other law enforcement training as may be mandated by the State of Illinois.


Section 2. Upon completion of the course of training, the officer shall file with the Mayor a certificate attesting to the completion of the required training.

Section 3. The Chief of Police is hereby directed to furnish a certified copy of this Ordinance to the Illinois Law Enforcement Training Standards Board.


Section 4. This Ordinance shall be in full force and effect immediately upon its passage.


