ORDINANCE NO. 608

AN ORDINANCE PROVIDING FOR THE LEVY AND ASSESSMENT OF TAXES FOR CORPORATE PURPOSES OF THE CITY OF SUMNER, ILLINOIS, BEGINNING ON MAY 1, 2012, AND ENDING ON APRIL 30, 2013

WHEREAS, on the 18<sup>th</sup> day of July, 2012, the City Council of the City of Sumner, Illinois, duly adopted and passed an Annual Appropriation Ordinance known as Ordinance No. 606 of the Ordinances of the City of Sumner, Illinois, making appropriations for corporate purposes for the City of Sumner, Illinois, for the fiscal year beginning May 1, 2012, and ending April 30, 2013; and

WHEREAS, the said Annual Appropriation Ordinance, being Ordinance No. 606 of the City of Sumner, Illinois, was duly published in pamphlet form on the 18<sup>th</sup> day of July, 2012; and

WHEREAS, said Annual Appropriation Ordinance is now in full force and effect;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Sumner, Illinois, as follows:

SECTION 1. That of the sum of \$1,104,767.00, being the total amount of appropriations heretofore legally made for all corporate purposes of said City of Sumner, Illinois, for the fiscal year beginning May 1, 2012 and ending April 30, 2013, the sum of \$8,960.00 being the total amount to be collected from the tax levy for the current fiscal year for said City, be and the same is hereby levied and assessed upon all real, personal, railroad, telegraph, telephone and all other taxable property within the corporate limits of said City, and subject to taxation therein according to the valuation of such property as the same is assessed and equalized for State and City purposes for the current year, in accordance with the appropriations heretofore extended and made by said Annual Appropriation Ordinance adopted and passed as aforesaid.

SECTION 2. The amount so levied as set forth in Section 1 herein and the purpose for which said amounts are levied are as hereinafter set forth:



SECTION 4. There is hereby certified to the County Clerk of Lawrence County, Illinois, the several sums above, in the total amount of Eight Thousand Nine Hundred Sixty Dollars (\$8,960.00), which total amount the City of Sumner, Illinois, requires to be raised by taxation for the current fiscal year of the City, and the City Clerk of said City is hereby ordered and directed to file with the County Clerk of the County on or before the time required by law, a certified copy of this Ordinance.

SECTION 5. This Ordinance shall be termed "Annual Levy Ordinance" and shall be known as Ordinance No. 606 of the Ordinances of the City of Sumner, Illinois, and shall be in full force and effect upon its adoption, approval and publication as provided by law.
